

RESOLUTION NO. 1002

A RESOLUTION ESTABLISHING GARBAGE COLLECTION FEES AND RATES FOR THE CITY OF JUNCTION CITY AND REPEALING RESOLUTION NO. 980.

WHEREAS, Section 6 of Ordinance No. 265, authorizes the City Council to establish garbage collection rates and charges associated with the City's municipal garbage disposal system; and

WHEREAS, the garbage collection rates and charges shown on Exhibit A attached hereto more effectively cover the City's costs of providing garbage disposal services; and

WHEREAS, pursuant to ORS 294.160, at its meeting on October 13, 2009, the City Council provided an opportunity for interested persons to comment on the enactment of this Resolution and its proposed rate and charge increases; now, therefore

THE CITY OF JUNCTION CITY DOES RESOLVE AS FOLLOWS:

Section 1. Findings. The above recitals are hereby adopted as findings of fact supporting the adoption of the fees and charges set forth on Exhibit A to this Resolution.

Section 2. Rates and Charges. The garbage collection rate schedules attached as Exhibit A are hereby adopted as establishing the rates and charges for garbage collection services for the City of Junction City.

Section 3. Repealing Clause. Resolution No. 980 is hereby repealed.

Section 4. Effective Date. Whereas the rates and charges authorized for the services set forth in this Resolution are necessary to preserve the financial integrity of the City of Junction City, this Resolution shall take full force and effect as of November 21, 2009.

Resolution No. 1002 - EXHIBIT A

Rates for Garbage Collection Service

Within the City Limits of Junction City

Schedule 1 – Can Rates

Rates: The rates to be charged to all persons, firms or corporations shall be reasonable and uniform, taking into consideration the service rendered, and shall not be in excess of the rates as set by resolution of the City Council.

RESIDENTIAL RATES

One-stop-per-week service:

35 Gallon Container	\$ 17.37 per month
65 Gallon Container	\$25.22 per month
95 Gallon Container	\$33.07 per month

Additional stops shall be computed at the monthly rate multiplied by the number of stops in the week.

COMMERCIAL RATES

One-stop-per-week service

35 Gallon Container	\$ 17.37 per month
65 Gallon Container	\$25.22 per month
95 Gallon Container	\$33.07 per month

Additional stops shall be computed at the monthly rate multiplied by the number of stops in the week.

YARD DEBRIS RATES

One-stop-per-every-other-week-service

95 Gallon Container	\$1.50 per month
---------------------	------------------

Only yard debris, such as grass, leaves, and branches shall be placed within the yard debris dumpsters. Any other materials placed within the dumpster shall constitute a contaminated load and shall be charged a contaminated load fee as detailed in Schedule 3.

The rates specified above are subject to the following conditions and surcharges:

(a) Cans shall not exceed the following weights when filled:

35 Gallon Container	65 Gallon Container	95 Gallon Container
60 pounds	120 pounds	180 pounds

(b) The lids on the containers should be closed and the container should be placed at least five (5) feet away from any obstruction.

Failure to comply with with (a) and (b) above may result in no garbage pick-up until the next week and/or additional hourly charges.

(c) Extra charges of not less than \$4.36 shall be made for extra garbage that can be picked up automatically during the normal weekly pick up. Any pick ups requiring a 2nd trip and/or manual pick up will be billed at the hourly rate.

(d) Yard Debris service is not a year round service. The service shall begin in April of each year. The service may end in November of each year, or as otherwise set in the discretion of the Public Works Director or City Council. Customers shall be given a minimum of a 30 day notice of the change.

(e) During any period in which the Yard Debris Service is not active, a service fee shall not be charged.

(f) Service of any type other than dumpster service provided more frequently than once a week shall be chargeable at the monthly rate multiplied by the number of times that service is provided during the week.

(g) Garbage and recycling containers are the property of the City of Junction City. Containers are issued to customers, subject to availability, as requested. Any damage to or loss of containers will be charged to the customer to which the container has been issued. The billing and collection of these charges will be processed with the regular billing for garbage service.

Schedule 2 – Dumpster Rates

Garbage Dumpsters

Monthly rates for dumpster containers shall be charged as follows:

WILL-CALL DUMPSTERS

A delivery fee of twenty-five dollars (\$25) shall be charged to all citizens requesting incidental clean-up and will-call dumpsters. Dump rates for Will-Call and Clean-up dumpsters shall be as follows:

The rates specified above shall be subject to the following conditions:

(a) The City will not be required to pick up any dumpster without a minimum notice of 48 hours.

(b) Clean-up and will-call dumpsters shall be allowed on the customer's property for a period not to exceed seven (7) days.

(c) Clean-up and will-call dumpsters may be dumped more than once during the seven (7) day period. A dump fee, as stated above, will be charged for each dump. At the end of the seven (7) day period, the dumpster shall be removed and, if the dumpster has not been dumped during the period, a single dump fee shall be charged.

(d) Clean-up and will-call dumpsters will not be filled above the rim of the container. Failure to comply with this requirement may result in a double fee being charged to the citizen at the discretion of the Public Works Director.

(e) The following materials shall not be placed in any dumpster provided by the City:

Concrete, bricks, rocks, dirt/sod, chemicals of any kind, tires, composition roofing, paints or thinners, lumber larger than 2 x 4's, iron, household garbage.

YARD DEBRIS DUMPSTERS

A delivery fee of ten dollars (\$10) shall be charged to all customers requesting yard debris dumpsters. Dump rates for Yard Debris Dumpsters shall be as follows:

The rates specified above shall be subject to the following conditions:

(a) The City will not be required to pick up any container without a minimum notice of 48 hours.

(b) Yard debris containers smaller than 4 yards in size shall be allowed on the customer's property for a period not to exceed seven (7) days. Containers 4 yard or larger shall be allowed on the customer's property for a period not to exceed fourteen (14) days.

(c) Yard debris dumpsters may be dumped more than once during the time period allowed. A dump fee, as stated above, will be charged for each dump. At the end of the time period, the dumpster shall be removed and, if the dumpster has not been dumped during the period, a single dump fee shall be charged.

(d) Yard debris containers will not be filled above the rim of the container. Failure to comply with this requirement may result in a double fee being charged to the customer at the discretion of the Public Works Director.

(e) Only yard debris, such as grass, leaves, and branches shall be placed within the yard debris dumpsters. Any other materials placed within the dumpster shall constitute a contaminated load and shall be charged a contaminated load fee as detailed in Schedule 3.

Schedule 3 – Other Services and Charges

INFECTIOUS WASTE DISPOSAL

The following rate schedule is fixed for the collection and disposal of infectious waste as prescribed by ORS 459.386 through 459.405:

There shall be a handling fee of \$25 per container, plus a disposal fee charged as follows:

10 Gallon Container	\$16.00
20 Gallon Container	\$18.00
35 Gallon Container	\$20.00

RATES BY HOUR OR LOAD

The charges for removal of garbage and refuse by the hour or the load shall be as follows, and shall apply only where the material cannot by its nature be conveniently placed in containers of the types previously mentioned in this resolution:

(A) Hourly rates:

(1) Open bed truck and one man	\$38.20 per hour
(2) Open bed truck and two men	\$49.27 per hour
(3) Packer 20 yards and under--one man	\$49.27 per hour
(4) Packer 20 yards and under--two men	\$60.26 per hour
(5) Front-end loaders and one man	\$60.26 per hour
(6) Front-end loaders and two men	\$71.33 per hour
(7) Chipping Fee	\$85.00 per hour
(8) Brush Pickup/Hauling Fee	\$81.00 per hour

CONTAMINATED LOAD FEES

For recycling and yard debris, each container is limited by what can be placed in it, if a container is found to have other debris in it, it will be considered a contaminated load that must be dumped by the regular garbage truck. Any customer who contaminates a load shall be subjected to the following fees:
